# **Privacy Policy**

This policy explains Four Corner Puppies, LLC's privacy practices for https://www.fourcornerspuppies.com/ and services provided by Four Corner Puppies, LLC, a website owned and operated by Four Corner Puppies, LLC. By visiting this website, you are accepting the terms of this Privacy Policy. Any external links to other websites are clearly identifiable as such, and we are not responsible for the content or the privacy policies of these other websites.

Four Corner Puppies, LLC complies with the US - EU Safe Harbor framework and the US - Swiss Safe Harbor framework as set forth by the US Department of Commerce regarding the collection, use and retention of personal data from European Union member countries and Switzerland. Four Corner Puppies, LLC adheres to the Safe Harbor Privacy Principles of notice, choice, onward transfer, security, data integrity, access and enforcement. ## Information Collected or Received

Four Corner Puppies, LLC will not sell or disclose your name, email address or other personal information to third parties without your explicit consent, except as specified in this policy. As a Four Corner Puppies, LLC member you are required to provide a valid email address at registration.

Depending on which services you choose to use, Four Corner Puppies, LLC may require additional information, such as your name, kennel name, billing and payment information (including billing address, telephone number, credit card information), a telephone number, and/or a physical postal address. Four Corner Puppies, LLC may require information such as your social security number or tax ID, date of birth, bank account information, credit card information and/or other proof of identification in order to verify your identity and provide this service to you. Credit card information on an account may be stored and used for both billing and payment purposes.

Four Corner Puppies, LLC may contact members to confidentially request more information about themselves or their kennel or pets listed on the site, to ensure compliance with our rules. Your birthdate, gender, ethnicity will not be publicly displayed in connection to your account and activity on the Site.

Your email address is publicly displayed and connected to your Four Corner Puppies, LLC activity. Other people may see your date joined, feedback, ratings, profile information, pets listed for sale or for adoption, profile pages, sold listings, and personal reference comments. Four Corner Puppies, LLC automatically receives and records some information from your browser when you visit the site, such as your IP address, cookies and data about which pages you visit on the site through the use of log files provided by our third-party tracking-utility partners. This information helps us analyze and understand how the site works for members and visitors, and provide a more personalized experience for members and visitors.

Some members or visitors may connect to or register a Four Corner Puppies, LLC account using an external third-party application, such as Facebook, Google, or Twitter. Four Corner Puppies, LLC may receive some data from those connected third-party applications. Connecting

your Four Corner Puppies, LLC account to third-party applications or services is optional, and when you connect your account to an external app, you will be given the opportunity to grant permission.

Four Corner Puppies, LLC may receive or collect information (for example:

fourcornerpuppies@gmail.com) about a person who is not yet a registered Four Corner Puppies, LLC member (a "non-member") in connection with certain Four Corner Puppies, LLC features, including but not limited to: a non-member subscribing to an Four Corner Puppies, LLC newsletter, a member inviting a non-member to visit https://www.fourcornerspuppies.com/, or a non-member engaging in a transaction. Non-member information is used only for the purpose it was originally submitted to Four Corner Puppies, LLC. A non-member can contact Four Corner Puppies, LLC support if they do not want Four Corner Puppies, LLC to retain their information.

Four Corner Puppies, LLC uses the information described in this policy to provide and improve our services and products, for billing and payments, for identification and authentication purposes, to contact members or interested parties, and for general research and aggregate reporting.

Four Corner Puppies, LLC uses cookies to help keep track of items you put into your shopping cart including when you have abandoned your cart and this information is used to determine when to send cart reminder messages via SMS. The above excludes text messaging originator opt-in data and consent; this information will not be shared with any third parties.

Four Corner Puppies, LLC's Terms of Use require all account owners to be at least 18 years of age (or have the permission and supervision of a responsible parent or legal guardian), therefore, this policy does not discuss use of our site or services by minors.

#### **Choice Control**

We know members of our community value having control over their own information, and therefore Four Corner Puppies, LLC gives you the choice of providing, editing or removing certain information.

You may change or correct your Four Corner Puppies, LLC account information. Sellers may remove certain optional information you no longer wish to be publicly visible, such as your full name by replacing it with your Kennel Name.

For various reasons, Four Corner Puppies, LLC may contact you about our services or your activity. Some of these messages are required, service-related messages for members. Other messages are not required, and you can control which optional messages you choose to receive by changing your settings in your account.

If you have optionally connected your account to an external, third-party application, such as Facebook, Google, or Twitter, you can remove permission for the app by changing your account settings within the third-party application.

If you no longer wish to use Four Corner Puppies, LLC's services or receive service-related messages, then you may close your account.

# **Messages from Four Corner Puppies, LLC**

On occasion, Four Corner Puppies, LLC will contact you. Primarily, messages are delivered by email, and every account is required to keep a valid email address on file to receive messages. In some situations, Four Corner Puppies, LLC may contact you by telephone, SMS message or physical mail in order to provide you with information about products and features you may find of interest or to provide you with customer support.

Some messages from Four Corner Puppies, LLC are service-related and required for members. Examples of service-related messages include, but are not limited to: a welcome/confirmation email when you register your account, notification of a transaction, or correspondence with Four Corner Puppies, LLC's support team. Information Sharing; Disclosure

We want to respect your privacy. Four Corner Puppies, LLC will not sell or disclose personally identifiable information to third parties without your explicit consent, except as specified in this policy.

As part of the buying and selling process, Four Corner Puppies, LLC will facilitate the sharing of information between the two members involved in the transaction. As part of the buying or selling process, you may obtain another Four Corner Puppies, LLC member's email address, physical address, payment information, and/or other information. As described in Four Corner Puppies, LLC's Terms of Use, you have a limited license to use this information only for Four Corner Puppies, LLC-related communications or for Four Corner Puppies, LLC-facilitated transactions. Four Corner Puppies, LLC has not granted you a license to use the information for unsolicited commercial messages. Without express consent from that person, you must not add any Four Corner Puppies, LLC member to your email or physical mailing list.

From time to time, Four Corner Puppies, LLC may make various aspects of our database of Your Information available to other parties for promotions of and solicitations for their goods or services that may be of interest to Four Corner Puppies, LLC members. However, we will not distribute personal information about any individual -- in other words, while we might let our advertisers know that we have 1000 people in your zip code, we won't let third-party advertisers know that YOU live in your zip code. However, by accepting this Agreement, you expressly consent to such use and disclosure of non-personally identifiable information. Four Corner Puppies, LLC may release your personal information to a third-party in order comply with a subpoena or other legal requirement, or when we believe in good faith that such disclosure is necessary to comply with the law; prevent imminent physical harm or financial loss; or investigate or take action regarding illegal activities, suspected fraud, or violations of Four Corner Puppies, LLC's Terms of Use. We may disclose personally identifiable information to parties in

compliance with our Copyright and Intellectual Property Policy, as we in our sole discretion believe necessary or appropriate in connection with an investigation of fraud, intellectual property infringement, piracy, or other unlawful activity. In such events, Four Corner Puppies, LLC may disclose name, address, country, phone number, email address and company name. Four Corner Puppies, LLC is affiliated with a variety of businesses and works closely with them. These businesses may offer promotions or sell items or services to you through Four Corner Puppies, LLC's services. We reserve the right to transfer information (including your personal data) to a third party in the event of a sale, merger, liquidation, receivership or transfer of all or substantially all of the assets of our company provided that the third party agrees to adhere to the terms of our Privacy Policy and provided that the third party only uses your personal data for the purposes that you provided it to us. You will be notified in the event of any such transfer and you will be afforded an opportunity to opt-out.

# **Cookies Tracking Technologies**

A cookie is a piece of data stored on the user's hard drive containing information about the user. Usage of a cookie is in no way linked to any personally identifiable information while on our site. If a user rejects the cookie, they may still use our site. The only drawback to this is that the user will be limited in some areas of our site. Cookies are also used to track promotional discounts on our Site. Four Corner Puppies, LLC, may set and access Four Corner Puppies, LLC cookies on your computer. Four Corner Puppies, LLC lets other companies that show advertisements on some of our pages to set and access their cookies on your computer. Other companies' use of their cookies is subject to their own privacy policies, not this one. Advertisers or other companies do not have access to Four Corner Puppies, LLC cookies.
Four Corner Puppies, LLC may partner with third-party services who may use various tracking technologies, such as browser cookies or Flash cookies, to provide certain services or features. account information is protected by a password. It is important that you protect against unauthorized access of your account and information by choosing your password carefully, and keeping your password and computer secure by signing out after using our services. Four Corner Puppies, LLC will track the computers, smartphones, and/or any other internet device that is used to access your account including your internet provider and IP Address. If we detect an attempt to sign into your account from a device or internet provider not previously associated with your account then you will be required to input a verification code that will be sent to the email address on file. The code will also be sent as a text message to your mobile phone on file whereas standard message and data rates may apply.

Four Corner Puppies, LLC encrypts sensitive information (such as credit card number) using secure socket layer technology (SSL). Four Corner Puppies, LLC follows generally accepted industry standards to protect the personal information submitted to us, both during transmission and once Four Corner Puppies, LLC receives it. #### **Data Retention**

Four Corner Puppies, LLC will retain your information only for as long as is necessary or your account is active or as needed to provide you services. If you no longer want Four Corner Puppies, LLC to use your information to provide you services, you may close your account. Four Corner Puppies, LLC will retain and use your information as necessary to comply with our legal obligations, resolve disputes, and enforce our agreements.
